How to reserve a locker:

Lockers are assigned on a first come-first served basis. Please send in your completed application along with your credit card information or make checks out to "Ski Lifts Inc.". Please send your application and payment to: PO Box 1068, Snoqualmie Pass, WA 98068, Attn: Tami Thornton. You will have full access to your Alpental lockers during the winter season. Access to lockers at Summit Central and Summit West will be available when those Base Areas are in operation.

**-CONDITIONS-**

The "SEASON" is the time period from the first day The Summit begins winter ski/ride operations until the last day of winter ski/ride operations, generally from early December until mid-April. Equipment **must** be removed from lockers prior to the 7<sup>th</sup> day after the end of the SEASON. After this time the lockers will be opened and any contents remaining therein will be disposed. Ski Lifts, Inc. DBA The Summit at Snoqualmie, its parent, subsidiary and affiliated companies, its respective agents, officers, directors, owners, contractors, volunteers, employees, insurers, and real and personal property owners (collectively, the "Releasees") assume no liability for any loss whatsoever associated with an assigned locker. **Releasees cannot and do not guarantee the security of the contents of the locker.** In consideration of being permitted to rent a locker I agree to REALEASE, FOREVER DISHCHARGE, DEFEND, INDEMNIFY AND HOLD HARMLESS Releasees from any claim I, or any third party in connection with my locker rental and use, may bring as a result of physical injury and/or loss sustained in connection with my rental of a locker. This agreement shall survive and continue in force beyond the termination of the current SEASON with respect to any liability, injury and/or damage occurring prior to such termination.
